

## Job Description

### Regional Medical Advisor

The Regional Medical Advisor will work as a member of the Medical team alongside the German Commercial organisation to support Amicus marketed products across all therapeutic areas, as well as assist R&D in country activities. Based on the Medical Directors advice and in coordination with the commercial organisation, the Medical Advisor will help to execute the Medical Affairs strategy and support the German marketing activities for all Amicus` approved products. The position will provide operational support for activities related to Medical Information and Communication, Medical Education and Training, Investigator Initiated Trials (IITs), Key Opinion Leader (KOL) outreach. The position will also provide Clinical Development support as needed. The RMA will support the Medical Director in all aspects, i.e. representation of Amicus in scientific presentations, conferences, support for the Commercial Organisation while ensuring adherence to all Amicus` policies and procedures as well as local regulatory and legal requirements (compliance).
